# **BILL**

An Act to amend the Civil Aviation Act, Chap. 49:03

### THE CIVIL AVIATION (AMENDMENT) ACT, 2010

### **Explanatory Note**

(These notes form no part of the Bill but are intended only to indicate its general purport)

This Bill seeks to amend the Civil Aviation Act, Chap. 49:03 "the Act" to exempt the Trinidad and Tobago Civil Aviation Authority from radio licence fees and to allow the Minister to amend the Schedules by Order.

Clause 1 provides for the short title.

Clause 2 seeks to provide the interpretation provision.

Clause 3 seeks to amend section 71 of the Act to exempt the Authority from radio licence fees.

Clause 4 seeks to amend the Act by inserting a new section after section 71 to allow the Minister with responsibility for civil aviation to amend the Schedules by Order.

Clause 5 seeks to amend the First Schedule by removing the restriction relating to tenure of office. This amendment would now allow a member of the Board of the Authority to be eligible to hold office for more than two consecutive terms.

1. This Act may be cited as the Civil Aviation short title (Amendment) Act, 2010.

Interpretation Chap. 49:03 2. In this Act, "the Act" means the Civil Aviation Act.

**3.** Section 71 of the Act is amended by inserting the words "radio licence fees," after the words "corporation tax,".

Section 72 inserted

**4.** The Act is amended by inserting after section 71, the following section:

"Power to amend Schedules T2. The Minister may, by Order, amend the Schedules.".

First Schedule amended

**5.** The First Schedule is amended by deleting clause 2(2).
