REVOCATION OF APPOINTMENT OF A PRIVATE WAREHOUSE (*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A.
