DETERMINATION OF COMPENSATION TO DEPENDANTS OF DECEASED EMPLOYEE

Re Death of

a workman lately employed with Port Authority of Trinidad and Tobago

COMPENSATION in the above matter having been deposited with me under section 8 of the Workmen's Compensation Act, persons claiming to be the dependants of the said Hansen O'Brien are hereby required to appear before the Commissioner on WEDNESDAY THE 27TH DAY OF OCTOBER, 2010, at 9.00 o'clock in the forenoon at the Hall of Justice, Port-of-Spain, when the Commissioner shall proceed to determine the distribution thereof.

Proof of relationship of dependants to the deceased workman will be required by the Commissioner to be furnished by claimants at the enquiry. Such proof to be in the form of certificates of birth and of marriage as in the circumstances be necessary.

A claimant for funeral expenses of the deceased must submit and prove his claim to the Commissioner on or before the 27th day of October, 2010.
