PRIVATE BILL—AN ACT TO REPEAL AND REPLACE THE NATIONAL ECCLESIASTICAL COUNCIL OF SPIRITUAL BAPTIST CHURCHES OF TRINIDAD AND TOBAGO AND PROVIDE FOR THE ECCLESIASTICAL COUNCIL OF SPIRITUAL BAPTIST CHURCHES OF TRINIDAD AND TOBAGO

PUBLIC NOTICE is hereby given in accordance with Standing Order No. 83(3)(b)(i) of the House of Representatives that it is intended to introduce in the House of Representatives the above-mentioned Bill.
