

Public Statement of The Youth Training and Employment Partnership Programme Limited

In compliance with Section 7, 8 and 9 of The Freedom of Information Act 1999

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, 1999 (FOIA) The Youth Training and Employment Partnership Programme Limited (YTEPP) is required by law to publish the following statement, listing the documents and information generally available to the public.

The following information is published by YTEPP with the approval of the Minister of Science, Technology & Tertiary Education.

The FOIA gives members of the public:

- | A legal right with exemptions for each person to access information held by a public authority;
- | A legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading;
- | A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA;
- | A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

FUNCTION, STRUCTURE AND EFFECTS ON MEMBERS OF THE PUBLIC

YTEPP traces its origins to 1988, as a short-term training intervention to address the then growing problem of high unemployment among young persons fifteen (15) to twenty-five (25) years of age. Subsequently, in 1990, YTEPP was incorporated as a limited liability company wholly owned by the Government of the Republic of Trinidad and Tobago. The company has become a primary provider of accredited technical and vocational education and training for young persons at the pre-craft and craft levels of the training hierarchy.

The training offered by the company consists of three main components, technical and vocational skills, life skills (career enhancement) and micro-entrepreneurship training. Technical and vocational skills training equip participants with practical skills for employment and self-employment. Life-skills training, on the other hand, addresses participants' attitudes to work and levels of literacy and numeracy. Micro-entrepreneurship training emphasizes the development of entrepreneurial skills and attitudes with a view to empowering participants to embrace entrepreneurship. Beyond these core components, the company's training offering has expanded to include customized training in computer applications.

Training is provided at over twenty centres and in communities throughout Trinidad and Tobago. Typically, two six-month cycles of training are completed in a calendar year, during which upwards of six thousand young persons are trained.

Graduate support services provided by the company complement its training. Among the services the company provides are job placement, business support for the self-employed, on-the-job training and business development seminars.

YTEPP is managed by a Board of Directors, appointed by the Government of Trinidad and Tobago, and an Executive Management Team headed by a Chief Executive Officer. Other members of the Executive Management Team are the Directors of Operations, Entrepreneurial Development Support Services and Finance and Information Technology. At June 2009, there were approximately 153 permanent employees, 389 temporary employees, 27 casual employees and 3700 trainees in the programme.
