THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, CHAP. 48:50

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(ST. PETER'S DAY CELEBRATIONS) ORDER, 2010

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (St. Peter's Day Celebrations) Order, 2010.
2. This Order has effect between the hours of 10.00 a.m. and 10.00 p.m. Duration on Sunday 27th June, 2010.
3. Vehicular traffic is prohibited on Western Main Road, between School Street and Abbe Poujade Street. Traffic restriction
4. Parking is prohibited on the following: Parking prohibited
 - (a) Western Main Road, between School Street and Abbe Poujade Street;
 - (b) Haig Street, between Western Main Road and Abbe Poujade Street;
 - (c) Beard Street, between Western Main Road and Francois Street;
 - (d) Constabulary Street, between Western Main Road and Sobion Street;
 - (e) Hope Street, between Haig Street and Beard Street;
 - (f) School Street, between Western Main Road and Francois Street;
 - (g) Francois Street, between School Street and Beard Street;
 - (h) Dwyer Street;
 - (i) Sobion Street; and
 - (j) Raymond Street.
5. (1) Vehicular traffic proceeding in a westerly direction from Western Main Road, Carenage shall proceed north along School Street, turning west onto Dwyer Street, south onto Constabulary Street, west onto Sobion Street, turning north onto Beard Street, west onto Traffic routes

Hope Street, south onto Haig Street, turning west onto Raymond Street, turning south along Abbe Poujade Street and onto Western Main Road.

(2) Vehicular traffic proceeding in an easterly direction from Western Main Road, Carenage shall proceed north along Abbe Poujade Street, south onto Haig Street, east along Hope Street, north along Beard Street, turning east onto Francois Street, south along School Street and onto Western Main Road.

6. Drivers shall proceed in a westerly direction only along the following:

- (a) Dwyer Street;
- (b) Sobion Street; and
- (c) Raymond Street.

Removal and
impounding
of vehicles
unlawfully
parked

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
