MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(FORMAL OPENING OF THE 2010–2011 LAW TERM OF  
THE SUPREME COURT OF JUDICATURE OF THE  
REPUBLIC OF TRINIDAD AND TOBAGO) ORDER, 2010

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Formal Opening of the 2010–2011 Law Term of the Supreme Court of Judicature of the Republic of Trinidad and Tobago) Order, 2010.

2. This Order has effect from 6.00 a.m. to 2.00 p.m. on Thursday 16th September, 2010.

3. (1) Parking is prohibited on the following:

- (a) St. Vincent Street, between Duke Street and Independence Square North;
- (b) Sackville Street, between Richmond Street and St. Vincent Street;
- (c) Abercromby Street, between Independence Square North and Park Street;
- (d) Knox Street, between St. Vincent Street and Frederick Street;
- (e) Edward Street, between Independence Square North and Park Street;
- (f) Hart Street;
- (g) Duke Street, between Frederick Street and Edward Street;
- (h) Pembroke Street, between Knox Street and Park Street;
- (i) Henry Street, between Independence Square North and Park Street; and
- (j) Queen Street, between Frederick Street and Edward Street.

Parking prohibited

(2) Notwithstanding subclause (1), vehicles belonging to the Police Service and the Defence Force may park on the eastern side of Edward Street, between Queen Street and Sackville Street.

(3) Parking is prohibited on the grounds of the Red House.

| Removal and impounding of vehicles unlawfully parked | <p>7. Without prejudice to any liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.</p>   |
