REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE  
MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF  
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)  
(CUREPE/SADDLE ROAD/EASTERN MAIN ROAD)  
REGULATIONS, 2011

1. These Regulations may be cited as the Traffic Control<sup>Citation</sup>  
(Experimental Scheme) (Curepe/Saddle Road/Eastern Main Road)  
Regulations, 2011.

2. These Regulations shall commence on Monday 14th March, 2011<sup>Duration</sup>  
and expire on Monday 13th June, 2011.

PART I

CUREPE

3. Maxi-taxis that ply the Curepe to Chaguanas route shall do so<sup>Maxi-taxi</sup>  
on the northern and southern lanes of Havelock Street, facing east,<sup>route</sup>  
between Southern Main Road and Broome Street.

4. Maxi-taxis that ply the Curepe to Chaguanas route shall not<sup>No entry to</sup>  
enter—<sup>maxi-taxis</sup>

- (a) the Southern Main Road, between the Eastern Main Road and Havelock Street;
- (b) Broome Street, between Havelock Street and Evans Street;
- (c) Market Street, between Havelock Street and Evans Street;
- (d) Phillip Street, between Southern Main Road and McDonald Street;
- (e) Harris Street, between the Southern Main Road and McDonald Street;
- (f) Clifford Street, between the Southern Main Road and McDonald Street;
- (g) McDonald Street, between Phillip Street and Evans Street;  
and
- (h) Evans Street East, between Clifford Street and the Southern Main Road.

- One-way traffic            5. Motorists shall proceed in an easterly direction on Havelock Street, between the Southern Main Road and Broome Street.
- No plying for hire        6. Taxidriviers may not ply for hire their taxis or maxi-taxis on Broome Street, between Fowler Street and Havelock Street.
- Parking prohibited        7. Parking is prohibited on Agostini Street, Curepe, from Evans Street onwards to a point two hundred metres east.

PART II  
SADDLE ROAD

- Parking prohibited        8. Parking is prohibited on Saddle Road between—  
                                   (a) Blanc Street and Sinanan Street; and  
                                   (b) Sam Boucaud Extension and Cantaro Extension.

PART III  
EASTERN MAIN ROAD

- No stopping or waiting    9. Motorists shall not stop or wait on the northern and southern sides of the Eastern Main Road to a point one hundred and fifty metres east and one hundred and twenty metres west of the main driveway of the Immigration Detention Centre (IDC), Aripo.

PART IV  
GENERAL

- Offence and penalty        10. Any person who contravenes these Regulations is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars and on any subsequent conviction to a fine of one thousand dollars.
- Removal and impounding of vehicles unlawfully parked Chap. 48:50            11. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
