THE LAND ACQUISITION ACT, CHAP. 58:01

NOTICE OF LAND LIKELY TO BE REQUIRED FOR A
PUBLIC PURPOSE

NOTICE is hereby given that it appears to the President that the parcels of land described in the Schedule and situate between the Diego Martin Highway southbound carriageway from Western Main Road to north of Acton Court and from the Diego Martin Main Road from Western Main Road to Victoria Gardens, in the Ward of Diego Martin, in the County of St. George are lands likely to be needed for a purpose, which in the opinion of the President is a public purpose: expansion of the Diego Martin Highway.

SCHEDULE

Thirteen parcels of land together comprising approximately 2,752 square metres situate between the Diego Martin Highway southbound carriageway from Western Main Road to north of Acton Court and from the Diego Martin Main Road from Western Main Road to Victoria Gardens, in the Ward of Diego Martin, in the County of St. George and further described as follows:

- (a) 62 square metres more or less situate at Lot No. A2, Diego Martin Main Road, Diego Martin and said to belong now or formerly to M. St. Hilaire;
- (b) 155 square metres more or less situate at Lot No. A3, Corner Diego Martin Main Road and Morne Cocoa Road, Diego Martin and said to belong now or formerly to M. Soares;
- (c) 12 square metres more or less situate at Lot No. A4, Corner Diego Martin Main Road and Morne Coco Road, Diego Martin and said to belong to the Trinidad and Tobago National Petroleum Marketing Company Limited;
- (d) 16 square metres more or less situate at Lot No. A5, Morne Coco Road, Diego Martin and said to belong now or formerly to Jillian Wallace;
- (e) 26 square metres more or less situate at Lot No. A6, Diego Martin Main Road, Diego Martin and said to belong to V. Moo;
- (f) 10 square metres more or less situate at Lot No. A7, Diego Martin Main Road, Diego Martin and occupied by George Sharpe;
- (g) 73 square metres more or less situate at Lot No. A8, Diego Martin Main Road, Diego Martin and said to belong formerly to Bayshore Enterprises Ltd. and now to G. Aboud;
- (h) 315 square metres more or less situate at Lot No. A9, Diego Martin Main Road, Diego Martin and said to belong formerly to Progressive Enterprises Ltd. and now to G. Aboud;
- (i) 135 square metres more or less situate at Lot No. A10, Diego Martin Highway, Diego Martin and said to belong to Trinidad and Tobago National Petroleum Marketing Company Limited;

- (j) 1676 square metres more or less situate at Lot No. A13, Diego Martin Highway, Diego Martin and presently being occupied by the Housing Development Corporation;
- (k) 100 square metres more or less situate at Lot No. A15, Diego Martin Highway, Diego Martin and which owner is unknown;
- (l) 11 square metres more or less situate at Lot No. A16, Corner Cocorite Farm Road and Western Main Road, St. James and which owner is unknown;
- (m) 161 square metres more or less situate at Lot No. A17, Corner Powder Magazine Road and Western Main Road, St. James and which is vacant and its owner unknown.
