REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE  
MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF  
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)  
(CHAGUANAS) REGULATIONS, 2011

1. These Regulations may be cited as the Traffic Control Citation  
(Experimental Scheme) (Chaguanas) Regulations, 2011.
2. These Regulations shall commence on Monday 28th March, 2011 Duration  
and expire on Sunday 26th June, 2011.
3. Vehicular traffic shall proceed on Ramsaran Street, between the Two-way  
Southern Main Road and Marc Street, in both an easterly and westerly traffic  
direction.
4. Parking is prohibited on— Parking  
prohibited
  - (a) the Southern Main Road, between Factory Road and the  
Triangle in Chase Village; and
  - (b) Factory Road, between the Southern Main Road and  
Perseverance Road.
5. Vehicular traffic shall proceed in a— One-way  
traffic
  - (a) southerly direction only on Andrew Street, between the  
Southern Main Road and Algernon Street; and
  - (b) westerly direction only on 10th Avenue, Orchard Gardens,  
between Xavier Street Extension and Wilking Boulevard,  
between the hours of 7.00 a.m. to 9.00 a.m. and 2.00 p.m. to  
4.00 p.m. Monday to Friday except on public holidays.
6. Motorists proceeding east along the Southern Main Road shall No right turn  
not turn right onto Andrew Street.
7. Any person who contravenes these Regulations is liable on Offence and  
summary conviction for a first offence to a fine of seven hundred and penalty  
fifty dollars and on any subsequent conviction to a fine of one thousand  
dollars.

8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
