BYE-LAWS

MADE BY THE PILOTAGE AUTHORITY WITH THE APPROVAL OF THE  
MINISTER UNDER SECTION 7 OF THE PILOTAGE ACT

THE PILOTAGE (AMENDMENT) BYE-LAWS, 2012

1. These Bye-laws may be cited as the Pilotage (Amendment) Citation  
Bye-laws, 2012.
2. In these Bye-laws, “the Bye-laws” means the Pilotage Bye-laws. Interpretation
3. Clause 17 of the Bye-laws is amended in— Clause 17  
amended
  - (a) paragraph (a), by inserting the words “and Tembladora”  
immediately after the word “Chaguaramas”, and by  
deleting the words “\$125.00” and substituting the words  
“\$175.00”;
  - (b) paragraph (b), by deleting the words “\$190.00” and  
substituting the words “\$300.00”;
  - (c) paragraph (c), by deleting the words “\$190.00” and  
substituting the words “\$300.00”;
  - (d) paragraph (d), by deleting the words “\$190.00” and  
substituting the words “\$300.00”;
  - (e) paragraph (e), by deleting the words “\$325.00” and  
substituting the words “\$300.00”; and
  - (f) paragraph (f), by deleting the words “\$375.00” and  
substituting the words “\$300.00”.
4. Clause 32(1) of the Bye-laws is amended in— Clause 32  
amended
  - (a) subparagraph (a)(i), by deleting the words “\$900.00” and  
substituting the words “\$1,700.00”; and
  - (b) subparagraph (a)(ii), by deleting the words “\$1,700.00” and  
substituting the words “\$2,000.00”.

5. The First Schedule of the Bye-laws is repealed and the following Schedule is substituted:

“FIRST SCHEDULE

(Clauses 14 and 33)

<i>Description of ship</i>	<i>Dues payable in or out of any compulsory pilotage area</i>
Ships up to 2,500 tons	\$950.00
Tankers	\$950.00 plus an additional charge of 30 cents per ton for each ton in excess of 2,500 gross tonnage
Container ships and passenger ships	\$950.00 plus an additional charge of 17 cents per ton for each ton in excess of 2,500 gross tonnage
Other ships up to 15,000 gross tonnage	\$950.00 plus an additional charge of 17 cents per ton for each ton in excess of 2,500 gross tonnage
Other ships in excess of 15,000 gross tonnage	\$950.00 plus an additional charge of 30 cents per ton for each ton in excess of 2,500 gross tonnage.”.
