THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, CHAP. 48:50

#### REGULATIONS

- Made by the Commissioner of Police with the consent of the Minister of Transport under Section 67 of the Motor Vehicles and Road Traffic Act
- THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (PORT-OF-SPAIN/CHAGUANAS/MARAVAL/TUNAPUNA/ST. HELENA/ARIMA/VALSAYN SOUTH/ST. AUGUSTINE) REGULATIONS, 2012
- 1. These Regulations may be cited as the Traffic Control Citation (Experimental Scheme) (Port-of-Spain/Chaguanas/Maraval/Tunapuna/St. Helena/Arima/Valsayn South/St. Augustine) Regulations, 2012.
- 2. These Regulations shall have effect from Monday 16th July, Duration 2012 to Monday 15th October, 2012.

### PART I

# PORT-OF-SPAIN

- 3. A driver may proceed in both an easterly and westerly direction Two-way on Queen Street, between Richmond Street and St. Vincent Street.
  - 4. A driver shall not park on—

No parking

- (a) Hart Street, between St. Vincent Street and a marked point thirty metres eastwards;
- (b) Charlotte Street, between Park Street and Independence Square North;
- (c) Queen Street, between Richmond Street and St. Vincent Street:
- (d) Edward Street, between Queen Street and Independence Square North;
- (e) the eastern side of Edward Street, between Queen Street and Sackville Street, on Monday, Wednesday and Friday, except on public holidays;
- (f) the western side of Edward Street, between Queen Street and Sackville Street, on Tuesday and Thursday, except on public holidays;

- (g) Richmond Street, between London Street and Independence Square North;
- (h) the northern side of Queen Street, between George Street and Chacon Street, from 10.00 a.m. to 4.00 p.m. on Tuesday, Thursday and Saturday, except on public holidays;
- (i) the southern side of Queen Street, between George Street and Chacon Street, from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday, except on public holidays;
- (j) the northern side of Prince Street, between George Street and Henry Street, from 10.00 a.m. to 4.00 p.m. on Tuesday, Thursday and Saturday, except on public holidays;
- (k) the southern side of Prince Street, between George Street and Henry Street, from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday, except on public holidays;
- (1) the eastern side of George Street, between Prince Street and Independence Square North, from 10.00 a.m. to 4.00 p.m. on Tuesday and Thursday, except on public holidays;
- (m) the western side of George Street, between Prince Street and Independence Square North, from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday, except on public holidays;
- (n) the eastern side of George Street, between Duke Street and Prince Street, on Tuesday and Thursday, except on public holidays;
- (o) the western side of George Street, between Duke Street and Prince Street, on Monday, Wednesday and Friday, except on public holidays;
- (p) the western side of Henry Street, between Park Street and Independence Square North, on Tuesday, Thursday and Saturday, except on public holidays;
- (q) the eastern side of Henry Street, between Park Street and Independence Square North, on Monday, Wednesday and Friday, except on public holidays;
- (r) Dundonald Street, between Queen's Park West and Albion Street;
- (s) the northern side of Albion Street, between Dundonald Street and Chancery Lane;
- (t) the southern side of Park Street, between Victoria Square (West) and Victoria Square (East);
- (u) the eastern side of Frederick Street, between Park Street and Independence Square North, from 10.00 a.m. to 4.00 p.m. on Monday, Wednesday and Friday, except on public holidays; and

- (v) the western side of Frederick Street, between Park Street and Independence Square North, from 10.00 a.m. to 4.00 p.m. on Tuesday, Thursday and Saturday, except on public holidays.
- 5. Maxi-taxis plying for hire shall be parked as follows:

Maxi-taxi stands

- (a) a maximum of sixteen maxi-taxis operating the Port-of-Spain/Petit Valley route facing north, on the western side of Charlotte Street, from a marked point thirty-five metres south of its intersection with Park Street; and
- (b) a maximum of ten maxi-taxis operating the Port-of-Spain/Maraval route facing west, on the southern side of Duke Street, between Henry Street and Charlotte Street.

### PART II

### TUNAPUNA

- 6. A driver shall proceed in an easterly direction only on Well One-way Street, between Cochrane Street and Freeling Street.
- 7. A driver shall not turn left onto Well Street from Daniel James No left turn Terrace.

#### PART III

### St. Helena

8. A driver shall not park on Caroni South Bank Road, between No parking St. Helena Junction and Madras Road.

## PART IV

#### ARIMA

9. A driver shall not park on Tumpuna Road, between the middle No parking entrance of the Arima Presbyterian Primary School and a marked point seventy-five metres north or seventy-five metres south.

## PART V

#### MARAVAL

10. A driver shall not park on Dacca Street.

### PART VI

#### CHAGUANAS

No parking

11. A driver shall not park on Xavier Street, from 7.00 a.m. to 9.00 a.m., Monday to Friday, except on public holidays.

## PART VII

### Valsayn South

One-way traffic 12. A driver shall proceed in a northerly direction only on Taguaria Road, between Bimitti Street and the Chruchill-Roosevelt Highway, Monday to Friday, from 6.00 a.m. to 9.00 a.m., except on public holidays.

No entry

- 13. A driver shall not enter—
  - (a) Taguaria Road from the Churchill-Roosevelt Highway, from 6.00 a.m. to 9.00 a.m., Monday to Friday, except on public holidays; and
  - (b) Springvale Road from the Southern Main Road, from 6.00 a.m. to 9.00 a.m., Monday to Friday, except on public holidays.

## PART VIII

### ST. AUGUSTINE

No parking

14. A driver shall not park on the western side of St. John's Road, between the Eastern Main Road and a marked point forty metres northward.

No stopping

15. A driver shall not stop on the eastern side of St. John's Road, between the Eastern Main Road and a marked point forty metres northward.

Taxi stand

16. Taxis plying on the Mount Saint Benedict Monastery route for hire shall be parked on the eastern side of St. John's Road, between a marked point ten metres north of the Eastern Main Road and a marked point forty metres northward.

#### PART IX

# GENERAL

Offence and penalty

17. A person who contravenes any of the provisions of these Regulations is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars, and on any subsequent conviction to a fine of one thousand dollars.

18. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in  $^{\rm impounding\ of}$  contravention of these Regulations may be removed by the Police and  $^{\rm unlawfully}$  impounded and dealt with in accordance with section 108(1)(b) of the  $^{\rm parked}$  Motor Vehicles and Road Traffic Act.
