MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE  
MINISTER OF WORKS AND INFRASTRUCTURE UNDER SECTION 67(1)  
OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)  
(ST. JAMES/PORT-OF-SPAIN) REGULATIONS, 2013

1. These Regulations may be cited as the Traffic Control <sup>Citation</sup>  
(Experimental Scheme) (St. James/Port-of-Spain) Regulations, 2013.
2. These Regulations shall have effect from Monday 11th March, <sup>Duration</sup>  
2013 to Monday 10th June, 2013.

PART I

ST. JAMES

3. A driver shall proceed in—  
One-way  
traffic
  - (a) a southerly direction only on Mathura Street, from Western  
Main Road to Mucurapo Road;
  - (b) a southerly direction only on Nizam Street, from Western  
Main Road to Hyderabad Street;
  - (c) a southerly direction only on Broad Street, between Ethel  
Street and Finland Street;
  - (d) a southerly direction only on Bay Road, between Ethel  
Street and Mucurapo Road;
  - (e) a northerly direction only on Romeo Street, between  
Mucurapo Road and Western Main Road;
  - (f) an easterly direction only on Carlton Avenue, between  
Luckput Street and Lazzarrie Street;
  - (g) an easterly direction only on Church Street, between  
George Cabral Street and Bombay Street;
  - (h) a westerly direction only on Quamina Street, between  
Mooneram Street and George Cabral Street;
  - (i) a northerly direction only on Bengal Street, between  
Western Main Road and Patna Street;

- (j) a southerly direction only on Agra Street, between Western Main Road and its intersection with Madras Street;
- (k) a southerly direction only on Agra Street, Kathleen Street and Patna Street;
- (l) a northerly direction only on Madras Street, between Western Main Road and its intersection with Agra Street;
- (m) a northerly direction only on Calcutta Street, between Western Main Road and Patna Street;
- (n) a southerly direction only on Kandahar Street, between Patna Street and Delhi Street;
- (o) a southerly direction only on Baroda Street, between Delhi Street and Calcutta Street;
- (p) a southerly direction only on Bombay Street, between Kathleen Street and Western Main Road;
- (q) a northerly direction only on Mooneram Street, between Western Main Road and Kathleen Street;
- (r) a southerly direction only on Brunton Road, between Patna Street and Western Main Road;
- (s) a southerly direction only on Jerry Street, between Ranjit Kumar Street and Western Main Road;
- (t) a northerly direction only on Salazar Street, between Western Main Road and Angelina Street; and
- (u) a northerly direction only on Guthrie Street, between Kathleen Street and Patna Street.

No left turn

4. (1) A driver proceeding along Western Main Road in an easterly direction shall not turn left onto—

- (a) Romeo Street;
- (b) Jerry Street;
- (c) Brunton Road;
- (d) Bombay Street; and
- (e) Agra Street.

(2) A driver proceeding in a southerly direction along —

- (a) George Cabral Street;
- (b) Jerry Street; or
- (c) Brunton Road,

shall not turn left onto Quamina Street.

- (3) A driver proceeding in a northerly direction along—  
(a) Salazar Street; or  
(b) Mooneram Street,

shall not turn left onto Church Street.

(4) A driver proceeding along Romeo Street shall not turn left onto Carlton Avenue.

(5) A driver proceeding north along Lazarrie Street shall not turn right on reaching its intersection with Carlton Avenue.

5. (1) A driver proceeding north along—  
(a) Salazar Street; or  
(b) Bournes Road,

No right turn

shall not turn right on reaching its intersection with Quamina Street.

(2) A driver proceeding along Mathura Street shall not turn right on reaching its intersection with Carlton Avenue.

(3) A driver proceeding south along Lazarrie Street shall not turn right on reaching its intersection with Carlton Avenue.

- (4) A driver proceeding south along—  
(a) Jerry Street;  
(b) Bournes Road;  
(c) Brunton Road; or  
(d) Bombay Street,

shall not turn right on reaching its intersection with Church Street.

(5) A driver shall not turn right from Patna Street, to proceed south on Long Circular Road, between the hours of 6.00 a.m. and 6.00 p.m.

6. (1) A driver shall not enter—  
(a) Nizam Street, from Hyderabad Street, to proceed in a northerly direction;  
(b) Broad Street, from Finland Street;  
(c) Bay Road, from Panka Street, to proceed in a northerly direction;  
(d) Bay Road, from Pujadas Street, to proceed in a northerly direction;  
(e) Bay Road, from Avenue First, to proceed in a northerly direction;

No entry

- (f) Bay Road, from Mucurapo Road, to proceed in a northerly direction;
- (g) Bay Road, from Finland Street, to proceed in a northerly direction;
- (h) Romeo Street, from Western Main Road;
- (i) Romeo Street, from Carlton Avenue, to proceed in a southerly direction;
- (j) Romeo Street, from Finland Street, to proceed in a southerly direction;
- (k) Romeo Street, from Panka Street, to proceed in a northerly direction;
- (l) Mathura Street, from Panka Street, to proceed in a northerly direction;

(e) Mooneram Street; or  
(f) Salazar Street,  
proceeding in a westerly direction.

(3) A driver shall not enter Quamina Street from—  
(a) Bournes Road;  
(b) Jerry Street; or  
(c) Salazar Street,  
proceeding in an easterly direction.

No parking

7. (1) A driver shall not park on the northern side of Western Main Road, between Link Road and Long Circular Road from 6.00 a.m. to 9.00 a.m., Monday to Friday, except on public holidays.

(2) A driver shall not park on the southern side of Western Main Road, between Link Road and Long Circular Road from 3.00 p.m. to 6.00 p.m., Monday to Friday, except on public holidays.

(3) A driver shall not park on the western side of—  
(a) Mathura Street;  
(b) Romeo Street;  
(c) Ethel Street;  
(d) Dengue Street;  
(e) Vidale Street;  
(f) Weekes Street;  
(g) Nepal Street;  
(h) Cawnpore Street;  
(i) Lazarrie Street;  
(j) Salazar Street;  
(k) Jerry Street;  
(l) Bournes Road;  
(m) Brunton Road;

(5) A driver shall not park on the northern side of—

- (d) Hyderabad Street;
- (e) Church Street;
- (f) Quamina Street;
- (g) Kathleen Street;
- (h) Delhi Street;
- (i) Patna Street;
- (j) Ranjit Kumar Street; or
- (k) Angelina Street,

on Mondays, Wednesdays and Fridays, between the hours of 6.00 a.m. and 6.00 p.m., except on public holidays.

(6) A driver shall not park on the southern side of—

- (a) Carlton Avenue;
- (b) Finland Street;
- (c) Anderson Street;
- (d) Hyderabad Street;
- (e) Church Street;
- (f) Quamina Street;
- (g) Kathleen Street;
- (h) Delhi Street;
- (i) Patna Street;
- (j) Ranjit Kumar Street; or
- (k) Angelina Street,

on Tuesdays, Thursdays and Saturdays, between the hours of 6.00 a.m. and 6.00 p.m., except on public holidays.

(7) A driver shall not park on the western and eastern sides of Ethel Street, between Western Main Road and its intersection with Bay Road.

8. A driver shall not park on the western side of—

- (a) Benares Street; or
- (b) Clarence Street.



PART II  
PORT-OF-SPAIN

8. (1) A driver shall not turn right onto— No right turn

(a) Edward Street, from the westbound lane of Wrightson Road; or

(b) Sackville Street, from the westbound lane of Wrightson Road,

between the hours of 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays.

(2) A driver shall not turn right onto—

(a) Tragarete Road, from Gatacre Street; or

(b) Colville Street, from Ariapita Avenue,

between the hours of 6.00 a.m. and 6.00 p.m., Monday to Friday, except on public holidays.

9. A driver shall not turn left onto Edward Street, from Independence Square South. No left turn

10. A driver shall not make a “U” turn onto the— No “U” turn

(a) eastbound lane of Wrightson Road at its intersection with Sackville Street, from the westbound lane of Wrightson Road; or

(b) eastbound lane of Wrightson Road at its intersection with Edward Street, from the westbound lane of Wrightson Road,

between the hours of 3.00 p.m. and 6.00 p.m., Monday to Friday, except on public holidays.

11. A driver shall proceed in a northerly direction only on Edward Street, between Wrightson Road and Independence Square South. One-way traffic

GENERAL

12. (1) Subject to subregulation (2), a person who contravenes any of the provisions of these Regulations commits an offence and is liable on summary conviction to a fine of seven hundred and fifty dollars. Offence and penalty

(2) A person who is found guilty of subsequent contravention of any of the provisions of these Regulations is liable on summary conviction to a fine of one thousand dollars.

Removal and  
impounding of  
vehicles  
unlawfully  
parked

13. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
