MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER,
2013

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Point Fortin Borough Day Celebrations) Order, 2013.

2. This Order has effect between the hours of 6.00 p.m. on Friday Duration 3rd May, 2013 and 6.00 a.m. on Sunday 5th May, 2013.

3. Parking is prohibited on—

- (a) Bryce Road;
- (b) Reid Road;
- (c) Atlantic Link Road;
- (d) Main Field Road;
- (e) Morris Road;
- (f) Church Road;
- (g) Montano Street;
- (h) Nurse Street;
- (i) Alleyne Street;
- (j) School Road;
- (k) Point Fortin Main Road, between Dunlop Roundabout and Refinery Road;
- (l) Techier Main Road, between Handel Street and First Street;
- (m) Second Street, between First Street and Eastern Avenue;
- (n) Eastern Avenue, between Second Street and Point Fortin Main Road;
- (o) Warden Road, between Guapo-Cap-de-Ville Road and Southern Main Road; and
- (p) along the Emergency Route.

4. Drivers are prohibited from driving on—

- (a) Guapo-Cap-de-Ville Road, between Bryce Road and Richardson Street;

- (b) Wickham Street, between Bryce Road and Point Fortin Main Road;
- (c) Point Fortin Main Road, between Reid Road and Wickham Street;
- (d) Techier Main Road, between Handel Street and Frisco Roundabout; and
- (e) Bryce Road, between Wickham Street and Guapo-Cap-de-Ville Road.
- One-way traffic 5. Drivers shall proceed along—
- (a) Reid Road, between Point Fortin Main Road and Montano Street, in a westerly direction only;
- (b) Montano Street, between Bryce Road and Reid Road, in a southerly direction only;
- (c) Bryce Road, between Montano Street and Point Fortin Main Road, in an easterly direction only; and
- (d) Point Ligoure Road, between Point Fortin Main Road and Guapo-Cap-de-Ville Road, in a northerly direction only.
- Traffic routes 6. (1) Drivers entering Point Fortin shall proceed west along Reid Road from Point Fortin Main Road to Montano Street.
- (2) Drivers leaving Point Fortin from the Guapo-Cap-de-Ville Road shall proceed east along Reid Road, north onto Montano Street, east onto Bryce Road and then onto the Point Fortin Main Road.
- Emergency route 7. Drivers on an emergency shall proceed in a northerly direction from Atlantic Avenue, onto Point Ligoure Road, onto Refinery Road, onto Guapo-Cap-de-Ville Road, onto Clifton Hill Road, then continuing in a southerly direction onto Volunteer Road, onto Canaan Road, then continuing in an easterly direction onto Techier Main Road, and then south onto Eastern Avenue and then in an easterly direction onto the Point Fortin Main Road towards San Fernando.
- Taxi stands 8. (1) The San Fernando taxi stand will be relocated to the lay-by on the eastern side of Point Fortin Main Road, approximately 500 metres north of Frisco Roundabout.
- (2) The Cedros and Erin taxi stands will be relocated to the car park of the Point Fortin Catholic Church, on the eastern side of the Guapo-Cap-de-Ville Main Road, in the vicinity of the Guapo-Cap-de-Ville Main Road and Reid Road intersection.

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act. ^{Removal and impounding of vehicles unlawfully parked}
