CONDITIONS OF SALE

1. Duty equivalent to thirty per cent (30%) of the purchase price shall be payable to the Customs and Excise Division.
2. Fifteen per cent (15%) VAT shall be payable to the Customs and Excise Division of the Ministry of Finance.
3. Payment must be made to the Port Authority on the day of sale either by cash or certified cheque.
4. Persons failing to comply with condition (3) above will not be entertained at future Auction Sales held by the Authority.
5. Items, the sale of which has been disallowed by other Government Agencies, shall be removed from the list of articles to be auctioned.
6. All auctioned cargo must be removed from the Authority's Compound by the respective buyers within ten (10) days subsequent to the Auction Sale at which they were purchased.
7. Items sold but not claimed and removed by the respective buyers, as per (6) above, shall be resubmitted for sale by the Authority at the next Auction Sale.
8. Interested persons shall be allowed to view the cargo listed above on 28th December, 2004, between the hours 8.00 a.m. and 11.00 a.m. and 12.00 noon to 3.00 p.m. after having made appropriate arrangement with the Divisional Manager, Operations, who can be contacted at 623-2901 Ext. 179.
