THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) is currently implementing the Agriculture Sector Reform Programme—Technical Assistance Programme (ASRP—TAP), with funding support from the Inter-American Development Bank. One of the specific areas of reform in the overall ASRP—TAP is the Land Use Policy and Administration component that is aimed at the creation of a more dynamic land market as well as an improvement to land administration in Trinidad and Tobago.
