AMENDMENTS TO THE RULES OF RACING 2000

THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise of the following amendments to the Rules of Racing 2000:

Rule 71(1)—New:

The following Rules relating to claiming races shall apply to all claiming races as well as optional claiming races but, in optional claiming races they apply only to those horses entered to be claimed and any reference to claiming races shall be so construed.

The existing 71 to become 71(11).

Rules of Racing: Claiming:

98.(i): "A horse once entered/declared to start in a race and is withdrawn without the permission of the Racing Veterinarian; the owner or his duly appointed Authorised Agent or the Trainer of the said horse, shall be fined by the Stewards and the matter may be referred to the Authority.

Rule 100: Medication and Prohibited Substances:

E. Furosemide (Lasix)

2 (c): The failure of a trainer to have the horse brought to the detention barn at the appointed time shall render the horse ineligible to run in the specific race, the Stewards reserve the right to impose a fine on the Trainer of the horse for breach of this Rule.
