### LIFTING OF RESTRICTIONS ON IMPORTATION OF BIRDS AND BIRD PRODUCTS FROM UNITED STATES OF AMERICA

PLEASE be advised that with effect from 16th September, 2003, the Ministry of Agriculture, Land and Marine Resources has lifted the restrictions placed on the importation of Birds and Bird Products from California, Nevada, Arizona, New Mexico, Texas, Louisiana, Arkansas, Oklahoma and Colorado, which said restrictions were imposed as a result of the outbreak of Exotic Newcastle Disease in the United States of America.

These restrictions were published in the "*Trinidad and Tobago Gazette (Extraordinary)*" Volume 42, No. 36 dated 28th February, 2003 as item 325 and No. 66 dated 28th April, 2003, as item 648.

The lifting of these restrictions have become tenable as the United States Department of Agriculture has announced the eradication of Exotic Newcastle Disease (END) after the outbreak that began in October, 2002.
