TENDER FOR THE CONSTRUCTION OF AN EXTENSION TO THE PROPOSED NEW SAN FERNANDO MAGISTRATES COURT FOR THE JUDICIARY OF TRINIDAD AND TOBAGO

TENDERS are invited for the extension to the proposed New San Fernando Magistrates Court at the Eastern Credit Union Building, 1-3, Court Street, San Fernando, for the Judiciary of Trinidad and Tobago.

Tender documents may be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain.

Tenderers are required to pay a tender deposit of five hundred dollars (\$500.00) payable by cash or certified cheque to the Director of Contracts and attach the original receipt to their tender.

Tenders must be accompanied by valid Income Tax Certificate and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not later than six (6) months prior to the closing date of the tender. Tenders must also be accompanied by a Certificate of Compliance issued in accordance with the National Insurance Act.

The original tender document together with an additional copy each of the Form of Tender, Main Summary Sheet and priced Bill of Quantities will be received up to 1.00 p.m. on Thursday 14th September, 2006. Envelopes must be addressed to the Chairman, Central Tenders Board and clearly marked on the outside: "Tender for the Construction of an extension to the proposed New San Fernando Magistrates Court for the Judiciary of Trinidad and Tobago", and must be deposited in the Brown Tenders Box located in the lobby of the Board's Office.
