 - (a) The purchase price payable to the Port Authority.
 - (b) Customs Duty equivalent to thirty (30%) percent of the sale price shall be payable to the Customs & Excise Division.
 - (c) Any taxes or duties chargeable under any law other than duty imposed under the Customs Act calculated by reference to the purchase price.
- (4) Payment must be made to the Port Authority on the fall of the hammer either by cash or certified cheque. Debit/Credit cards will be accepted.
- (5) Persons failing to comply with condition (4) above will be debarred from further participating in the Auction Sales held by the Port Authority.
- (6) All auctioned cargo must be removed from the Authority’s Compound by the respective buyer/s within seven (7) working days subsequent to the Auction Sale, failing which store rent will be calculated, in accordance with the Port Authority’s Tariff.

As the pivotal agency for trade promotion and development, the Ministry manages and coordinates the trade reform process to enhance this country's competitiveness globally.

In its role as official Secretariat for the Prime Minister's Standing Committee on Business Development, the Ministry spearheads activities surrounding Government's strategic objective of diversifying the Trinidad and Tobago economy. This is closely tied to another important role, the development of Industry in Trinidad and Tobago.
