TENDER FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF SIX (6) STANDBY GENERATORS, AUTOMATIC TRANSFER SWITCHES AND ASSOCIATED ELECTRICAL WORKS FOR THE OPERATION OF TRAFFIC LIGHT SYSTEM AT SIX INTERSECTIONS OF THE CHURCHILL-ROOSEVELT HIGHWAY, MINISTRY OF WORKS AND TRANSPORT

TENDERS are invited for the Supply, Delivery, Installation and Commissioning of six (6) Standby Generators, Automatic Transfer Switches and associated Electrical Works for the operation of Traffic Light Systems at six (6) Intersections of the Churchill-Roosevelt Highway, Ministry of Works and Transport.

Tender documents may be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain.
