The object of the Bill is to supplement the appropriation provided for by the Appropriation Act, 2008, as amended by the Finance (Supplementation and Variation of Appropriation) Act, No. 7 of 2008 and the Finance (Supplementary Appropriation) Act, No. 18 of 2008 respectively, by authorizing the issue from the Consolidated Fund in the sum of One Thousand and Seventy Three Million, Nine Hundred and Eighteen Thousand, Seven Hundred and One Dollars (\$1,073,918,701).
