## PUBLIC STATEMENT OF THE STATUTORY AUTHORITIES' SERVICE COMMISSION IN COMPLIANCE WITH SECTIONS 7,8 AND 9 OF THE FREEDOM OF INFORMATION ACT (FOIA) 1999

1. In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, 1999 (FOIA) the Statutory Authorities' Service Commission is required by law, to publish a statement listing the documents held and the information available to the public.

- 2. The Freedom of Information Act gives members of the public:-
  - (1) A legal right for each person to access information held by the Statutory Authorities' Service Commission
  - (2) A legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading
  - (3) A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA
  - A legal right to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA

## Section 7 (1) (a) (i)

### Structure, Role and Function of the Statutory Authorities' Service Commission

The Statutory Authorities' Service Commission was established by Act #16 of 1966, which was amended by Acts #45 of 1979 and #8 of 1983. According to Sections 4(1) and 5(1) of the Statutory Authorities' Act Chapter 24:01, the Commission has the power to appoint persons to be or act as officers and to transfer, promote, remove and exercise disciplinary control over persons so appointed. An officer is defined as a person holding a pensionable office in the service of a Statutory Authority and whose remuneration is paid on a monthly basis.
