INJUNCTION—ILLEGAL INDUSTRIAL ACTION—CONTINUED

The above-mentioned Application having been heard by this Honourable Court on Tuesday 15th September, 2009 and leave having been granted to file all the documents herein on or before 4.00 p.m. on Tuesday, 15th September, 2009.

And upon Reading the Notice lodged herein on the 15th September, 2009.

And upon Reading the proposed Affidavit of Roslyn Khan Cummings lodged herein on the 15th day of September, 2009 together with the exhibits thereto.

And upon Senior Counsel for Party No. 1 undertaking to have the said proposed affidavit sworn to and the aforesaid documents filed herein on or before 4.00 p.m. on Tuesday 15th September, 2009.

And upon Mature Consideration and Deliberation it is Ordered that-

- (1) The Transport and Industrial Workers Union (hereinafter called "the Union") whether by its President General/President, General Secretary, Treasurer, Officers, Servants, workmen and/or agents and/or its members and/or all workers/members or employees who are workers of the Public Service Transport Corporation whether Drivers/Conductors thereof (hereinafter referred to as "PTSC Workers") or any of them or howsoever otherwise known, classified, designated, categorised, called and/or described be restrained from taking and/or continuing to take industrial action whether by way of protests, boycotts, sympathy strikes, refusal to work, refusal to operate the buses in accordance with the Public Transport Service Act, Chap. 48:02 and/or within the meaning of the Industrial Relations Act, Chap. 88:01 ("the Act") in relation to the PTSC's Main Entrance/Central Gate ("the Main Entrance") and/or any of its operating terminals.
- (2) The Union, its officers, servants and/or agents and/or its members and/or PTSC Workers engaged in Industrial Action be and are hereby enjoined from taking and/or continuing to take such industrial relation action.
- (3) PTSC Workers shall not take part in any Industrial Action in accordance with Section 67(2) of the Act.
- (4) PTSC Workers shall not take part in any Industrial Action either as commenced at or about 4.30 a.m. on Monday 14th September, 2009 at the Main Entrance or at all.
- (5) The Order made herein is without prejudice to any right accruing to the PTSC under Section 63(1)(c) of the Act in relation to all the PTSC workers who are at present engaged in industrial action.

And it is also Ordered that leave be and the same is hereby granted to serve a copy of the said proposed affidavit of Roslyn Khan Cummings lodged herein on the 15th day of September, 2009 together with a copy of this Order on the Union with liberty to Party No. 1 to serve such other person or persons as Party No. 1 may deem fit.

And is further Ordered that this Order be published in the Trinidad and Tobago Gazette and once in two (2) daily newspapers circulating in Trinidad and Tobago.

Variation and Discharge of this Order:

And it is further Ordered that the Union may apply to this Court at any time to vary or discharge this Order (or so much of it as affects the Union) on condition that should the Union wish to do so it must first give at least 48 hours notice (Saturdays, Sundays and Public Holidays being excluded for the computation of time) to the Attorney-at-law for Party No. 1.
