ORDER OF THE COMMISSION

Dated this 13th day of August, 2009

WHEREAS:

1. Notices were issued to Chan Ramlal Limited for the contravention of by-law 19 (1) (a) of the Securities Industries (Take-Over) By-Laws, 2005 ("the By-Laws") and section 82 (c) of the Securities Industry Act, 1995 ("the Act") respectively.
2. The Hearing on these matters commenced on March 4, 2009 and directions were issued by the Hearing Panel for the conduct of the Oral hearing.
3. On July 9, 2009 the Oral hearing was converted to a Written Hearing.
4. Upon Chan Ramlal Limited having accepted that it had contravened by-law 19 (1) (a) which provides as follows:

19. (1) Every offeror that, except pursuant to a formal bid, acquires beneficial ownership of, or the power to exercise control or direction over, or securities convertible into, voting or equity securities of any class of a reporting issuer that together with such offeror's securities of that class, would constitute ten percent or more of the outstanding securities of that class-

(a) shall immediately issue and file with the Commission, a press release containing the information prescribed by by-law 31;

5. And Section 82 (c) of the Act, which provides:

82. No person shall, directly or indirectly, in connection with the purchase or sale of any security-

(c) make any untrue statement or omit to state a material fact with the intention to mislead.

6. Upon Chan Ramlal Limited having agreed to pay the maximum fine under section 143(1) of the Act in respect of its contraventions.
7. Upon Chan Ramlal Limited having paid the sum of One Hundred Thousand Dollars (\$100,000.00) into the Trinidad and Tobago Securities and Exchange Commission.
8. Upon hearing the attorneys at law for the staff of the Trinidad and Tobago Securities and Exchange Commission and Chan Ramlal Limited, the Settlement Agreement was signed.
9. The Hearing Panel has submitted the Settlement Agreement to the Commission for approval.

IT IS HEREBY ORDERED:

- (a) That the procedure outlined under the Securities Industry (Hearings and Settlements) Practice Rules, 2008 has been followed;
- (b) That the Settlement Agreement is approved by the Commission;
- (c) That the Respondent has contravened by-law 19 (1) (a) of the By-Laws and has paid the sum of \$50,000.00 as the maximum fine for its contravention;
- (d) That the Respondent has contravened section 82 (c) of the Act and has paid the sum of \$50,000.00 as the maximum fine for its contravention;
- (e) That Chan Ramlal Limited published a press release in a daily newspaper on its acquisition of more than 10% of the shares in Berger Paints Limited including the period of time in which the shares were held by Chan Ramlal Limited and filed the said release with the Commission;
- (f) That this Order shall be published in the Trinidad and Tobago Gazette and in the daily newspapers.

AND WHEREAS on the 19th day of March, 2009, the Staff of the Commission and the Respondent entered into settlement discussions;

AND WHEREAS on the 12th day of August 2009 the Respondent entered into a proposed settlement agreement with the Staff of the Commission which was signed by the duly authorized officer of the Respondent and the General Manager of the Commission on behalf of the Staff ("the Settlement Agreement");


AND WHEREAS the Settlement Panel approved the Settlement Agreement and agreed to submit the Settlement Agreement to the Commission;

AND WHEREAS the Respondent has paid the sum of thirty thousand dollars (\$30,000.00) to the Trinidad and Tobago Securities and Exchange Commission;


AND WHEREAS the Commission has considered the Settlement Agreement and is of the opinion that it is in the public interest to make this Order.

IT IS HEREBY ORDERED THAT:


- (a) The procedure outlined under the Securities Industry (Hearings and Settlements) Practice Rules, 2008 has been followed;

UPDATED PUBLIC STATEMENT OF THE TRINIDAD AND TOBAGO POSTAL CORPORATION 2008

In Compliance with Sections 7, 8 and 9 of the Freedom of Information Act 1999

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, 1999 (FOIA) the Trinidad and Tobago Postal Corporation (TTPOST) is required by law as a statutory body to publish certain information for the benefit of the public.

Function and Structure of the Trinidad and Tobago Postal Corporation

Mission Statement:

To provide innovative, competitive, high quality postal and other communications through motivated, well-trained and knowledgeable staff.

The Trinidad and Tobago Postal Corporation (**TTPost**) is a Statutory Corporation with a Board of Directors and is wholly owned by the Government of Trinidad and Tobago. TTPost was established by Act of Parliament. The Trinidad and Tobago Postal Corporation Act was assented to on February 10th, 1999 and proclaimed on July 1, 1999. The Corporation comprises a staff of 1,300 employees and is headed by the Managing Director who is also an executive member of the Board.

TTPost is divided into nine (9) responsibility centers, namely, the Operations, Sales and Marketing, Finance and Administration, Corporate Services, Human Resources Division, Procurement, Security and Communications Departments. The Divisions are headed by General Managers and the Departments by Managers who all report to the Managing Director. The Managing Director reports to the Board.

Under the Operations Division, there are the National Delivery Manager, the National Transport Manager and the Processing Shift Manager with their respective Team Leaders and staff. The Sales and Marketing Division has Managers and support officers in the areas of marketing, business development, retail, accounts, products and customer service. The information technology (IT), inventory and purchasing functions fall under the Finance and Administration Division and the Property Department under the Operations Division.

The Corporation's policy is to answer all requests, both oral and written. However, in order to exercise your rights under the FOIA (for example the right to challenge a decision if your request for information is refused), you must make your request in writing. You must therefore complete the appropriate form (*Request for Access to Official Documents*) available in our **Customer Service Department** for information that is not readily available to the public.

▪ Addressing Requests

To facilitate prompt handling of your request, please address it to the Designated Officer of the Public authority **(See Section 7 (1) (a) (vi))**.



- *Details in the Request*

Applicants should provide details that will allow for ready identification and location of the records that are being requested. If insufficient information is provided clarification will be sought from the applicant. If you are not sure how to write your request or what details to include, communicate with our Designated Officer. **(See Section 7 (1) (a) (vi)).**

Requests not handled under the FOIA

- A request under the FOIA, will not be processed to the extent that it asks for information, which is readily available to the public,, either from this public authority or from another public authority, for example brochures , pamphlets , reports etc.

Responding to your Request

- *Retrieving Documents*

TTPost is required to furnish copies of documents only when they are in the Corporation's possession or if they can be retrieved from storage. Information stored in the National Archives or another storage center, will be retrieved in order to process your request.

Prior to the commencement of the Freedom of Information Act, old records may have been destroyed. The granting of a request for such documents may, therefore be impossible. Various laws, regulations and manuals give the time periods for keeping records before they may be destroyed. For example, The Exchequer and Audit Act, Chap. 69:01.

- *Furnishing Documents*

An applicant is entitled to copies of information in the Corporation's possession, custody or power. TTPost is required to furnish only one copy of a document. If a legible copy of a document cannot be made to be released, TTPost may not attempt to reconstruct it. Instead, it will furnish the best copy possible and note its quality in its reply.



▪ *Furnishing Documents*

An applicant is entitled to copies of information in the Corporation's possession, custody or power. TTPost is required to furnish only one copy of a document. If a legible copy of a document cannot be made to be released, TTPost may not attempt to reconstruct it. Instead, it will furnish the best copy possible and note its quality in its reply.

Please note TTPost is not compelled to do the following:

- (a) Create new documents. For example, we are not required to write a new program so that a computer will print information in the format you prefer.
- (b) Perform research for you.

Time Limits

▪ *General*

The FOIA sets a time limit of thirty (30) calendar days for determination of your request for access to documents. If this deadline is not met, the FOIA gives you the right to proceed as though your request has been denied. TTPost will try diligently to comply with the time limit. If it appears that processing your request may take longer than the statutory limit, we will acknowledge your request and advise you of its status. Since there is a possibility that requests may be incorrectly addressed or misdirected, you may wish to call or write to confirm that we have received the request and to ascertain its status.

▪ *Time Allowed*

TTPost will determine whether to grant your request for access to information as soon as practicable but no later than 30 days as required by Section 15 of the FOIA. If a decision is taken to grant access to the information requested, you will be permitted to inspect the documents and/or be provided with copies.
