## **Publication of Inactive Accounts**

In accordance with the revised Financial Institutions Act 26 of 2008 by the Central Bank:

Section 76 (1) "Every licensee shall, within sixty days after the end of its financial year, publish in the Gazette and in at least two daily newspapers published and circulated in Trinidad & Tobago a statement showing all accounts payable by the licensee in respect of which, during a period of seven years or any longer period, no transaction has taken place and no statement of account has been requested or acknowledged by the creditor."

The following accounts have had no activity or requests for or acknowledgement of statements for the past seven years or longer. The person to whom the account is payable or his legal personal representative must submit a claim to the licensee on or before 26th February 2010, to the respective branch, to have the account returned to an active status. Failure to do so will result in the transferring of the account to the Central Bank of Trinidad & Tobago. The presentation of valid identification is required to complete this transaction.
