## APPOINTMENT OF PRIVATE WAREHOUSES

*(Customs Act, Chap. 78:01)*

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the places specified in the Schedule hereto to be Private Warehouses for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouses of Messrs. York Garments Limited trading as Gone Bananas Duty Free clothing apparel, alcohol, snacks, drinks, souvenir items, tobacco and such other goods as I may subsequently approve.

## SCHEDULE

## 3 SHOPS OF GONE BANANAS

**Shop 1**

Is an enclosed area located on the ground floor of the eastern side of Piarco Airport Terminal Building measuring 78.57 square metres. Bounded on the north by Skyway and on the south by Dufry In Bond Shops. The eastern side is the Tobago Ramp and on the west is a wide corridor leading up to the departure stairway which also separates the eastern from the western shops. Concrete walls surround the shop. The ceiling is of gypsum tiles and the floor is tiled concrete. Access is gained through a glass door on the western side.

**Shop 2**

It occupies an area of 134.15 square metres. Gypsum walls faced with plywood surrounds three (3) sides of the shop. The fourth side which is the front, there is a metal sliding gate through which access is gained from the corridor that runs east to west. The ceiling is of gypsum and the floor is tiled concrete.

**Shop 3**

Is an enclosed area located on the first floor in the western section of the Piarco Airport Terminal Building in the In Bond shop area. This shop is located on the left side after the washroom and security departure check point, facing departure gate 2. It is bounded on the east by the washroom, on the west by the waiting area to departure Gate 7, on the south a concrete wall, on the north by the corridor that runs from east to west. It occupies an area of 114.30 square metres. Gypsum walls faced with plywood surround three (3) sides of the shop. The fourth side which is the front, there is a metal roll up gate through which access is gained from the corridor that runs east to west. The ceiling is of gypsum and the floor is tiled concrete.

The three (3) shops to be bonded occupies an area of 327.02 square metres.
