TENDER FOR THE SUPPLY, DELIVERY, COMMISSIONING, OPERATOR TRAINING, CALIBRATING, SERVICING AND MAINTENANCE OF FORTY-SIX ADVANCE LIFE SUPPORT MONITORS FOR THE NATIONAL EMERGENCY AMBULANCE SERVICE OF THE MINISTRY OF HEALTH

TENDERS are invited for the supply, delivery, commissioning, operator training, calibrating, servicing and maintenance of forty-six (46) Advance Life Support Monitors for the National Emergency Ambulance Service of the Ministry of Health.

Tender documents may be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain.

Tenderers are required to pay a tender deposit of one thousand dollars (\$1,000.00) either by cash or certified cheque to the Director of Contracts and attach the original receipt to their tender. Payments will be received from Monday to Friday between the hours of 8.30 a.m. to 12.00 noon and 1.00 p.m. to 2.00 p.m.

Tenders must be accompanied by the following:

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender;
- (b) a valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and five (5) copies of the Tender should be placed in sealed envelopes, addressed to the Chairman, Central Tenders Board, 116, Frederick Street, Port-of-Spain and clearly marked on the outside: "Tender for the Supply, Delivery, Commissioning, Operator Training, Calibrating, Servicing and Maintenance of forty-six (46) Advance Life Support Monitors for the National Emergency Ambulances Service of the Ministry of Health".
