Required Qualifications, Experience and Skills

Minimum qualifications: LLB and a professional legal qualification such as the LEC—Legal Education Certificate.

- 1. Draws up and issues under the hand of the Registrar and the seal of the Court orders transmitting the decisions of the Court to the parties to the dispute.
