APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the places specified in the Schedule hereto to be Private Warehouses for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs: Dufry Trinidad Limited—Jewellery, Watches, Alcohol, Tobacco, Perfumery and such other goods as I may subsequently approve.

SCHEDULE

Bonded Warehouse

- (i) Two adjoining areas within the building, one being 9.90 metres long and 6.10 metres wide, the other being 7.30 metres long and 4.90 metres. A total of 96.16 square metres.
- (ii) The building is constructed of concrete walls, floors of reinforced concrete and a gypsum ceiling, with a roof of wooden rafters and galvanized sheets and two (2) steel doors as access.
- (iii) The building is located east of the V.I.P. thoroughfare of the South Terminal Compound—Piarco International Airport.
- (iv) The building is bounded on the north by Piarco International Airport Runway, on the south by Caroni South Bank Road, on the east by Old Piarco Terminal Building and on the west by Golden Grove Road.

In Bond Shop No. 1

Access is gained by a glass sliding door on an aluminum frame.

The area is bounded on the north by the ramp area, on the south by the intransit area, (gates 1–7), on the east by NEDCO and on the west by Stetchers In-Bond Shop. The shop is inside the airport building.
