PRIVATE BILL—AN ACT FOR THE INCORPORATION OF THE TRINIDAD AND TOBAGO FOOTBALL FEDERATION
AND FOR MATTERS INCIDENTAL THERETO

PUBLIC NOTICE is hereby given in accordance with Standing Order No. 83(3)(b)(i) of the House of Representatives that it is entitled to introduce in the House of Representatives the above-mentioned Bill.
