NOTICE OF LAND LIKELY TO BE REQUIRED FOR A PUBLIC
PURPOSE

NOTICE is hereby given that it appears to the President that the parcels of land described in the Schedule and situate in the Ward of St. Ann's in the County of St. George are lands likely to be needed for a purpose, which in the opinion of the President is a public purpose: to facilitate construction of an overpass East of the Aranguez Main Road along the Churchill-Roosevelt Highway and two (2) parallel feeder roads on either side of the Churchill-Roosevelt Highway linking El Socorro and Aranguez Roads.

SCHEDULE

- (a) A corridor of land traversing several parcels of private land beginning at point A01 at co-ordinate 670,135E, 1,175,469N in the Ward of St. Ann's in the County of St. George and continuing along points to point A26 at co-ordinate 670,182E, 1,175,465N.
- (b) A corridor of land traversing several parcels of private land beginning at point B27 at co-ordinate 670,493E, 1,175,380N in the Ward of St. Ann's in the County of St. George and continuing along points to point B51 at co-ordinate 670,417E, 1,175,384N.
- (c) A corridor of land traversing several parcels of private land beginning at point C52 at co-ordinate 669,120E, 1,175,619N in the Ward of St. Ann's in the County of St. George and continuing along points to point A01 at co-ordinate 670,135E, 1,175,469N.
- (d) A corridor of land traversing several parcels of private land beginning at point B40 at co-ordinate 670,154E, 1,175,400N in the Ward of St. Ann's in the County of St. George and continuing to point D67 at co-ordinate 669,828E 1,175,420N and continuing along points to point D74 at co-ordinate 669,088E, 1,175,563N.
- (e) A corridor of land traversing several parcels of private land beginning at point D75 at co-ordinate 669,734E, 1,175,236N in the Ward of St. Ann's in the County of St. George and continuing to point B36 at co-ordinate 670,146E, 1,175,249N.

- (f) A corridor of land traversing several parcels of private land beginning at point D76 at co-ordinate 669,736E, 1,175,215N in the Ward of St. Ann's in the County of St. George and continuing to point B35 at co-ordinate 670,149E, 1,175,229N.
