## REGULATIONS

Made by the Commissioner of Police with the consent of the MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

# THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (NO. 5) REGULATIONS, 2009

- 1. These Regulations may be cited as the Traffic Control Citation (Experimental Scheme) (No. 5) Regulations, 2009.
- 2. These Regulations shall have effect from Monday 3rd August, Duration 2009 to Monday 2nd November, 2009.

#### San Juan

3. Parking is prohibited on—

Parking

- (a) Mission Road, on the southern side, from Saddle Road to prohibited Nicholas Avenue;
- (b) Prizgar Road, on the northern side from Saddle Road to Third Avenue;
- (c) First Street, on the northern side and southern side, from Saddle Road to Third Avenue;
- (d) Second Street, on the northern side and southern side, from Third Avenue to Saddle Road:
- (e) Saddle Road, on the eastern side, from Mission Road to Eastern Main Road; and
- (f) Saddle Road, on the western side, from Mission Road to Eastern Main Road.

#### 4. Motorists shall proceed in—

One-way

traffic

- (a) a northerly direction on Saddle Road, from Eastern Main Road to First Street;
- (b) an easterly direction on Mission Road, from Nicholas Avenue to Saddle Road;
- (c) a westerly direction on Prizgar Road, from Saddle Road to Third Avenue;

- (d) a westerly direction on First Street, from Saddle Road to Third Avenue;
- (e) an easterly direction on Second Street, from Third Avenue to Saddle Road;
- (f) an easterly direction on First Street, on the eastern side, from Saddle Road to Eastern Main Road; and
- (g) a westerly direction on Second Street, from First Street to Saddle Road.

No entry to maxi-taxis

5. Maxi-taxis plying the Santa Cruz to San Juan route shall not enter on First Avenue, from First Street to Second Street.

No entry

6. Motorists are prohibited from entering on Saddle Road, from First Street to Eastern Main Road.

Maxi-Taxi Stand 7. A maximum of six maxi-taxis plying the Santa Cruz/La Canoa route shall park on the southern side of First Street, as marked.

Taxi Stand

- 8. Taxis plying for hire shall park as follows:
  - (a) A maximum of ten taxis operating—
    - (i) the Laventille/Sunshine Avenue route shall park facing west on the northern side of Prizgar Road, as marked;
    - (ii) the Santa Cruz route shall park facing west on the northern side of Second Street, as marked; and
  - (b) a maximum of six taxis operating the La Canoa route shall park facing west on the southern side of Second Street, as delineated.

Loading and off-loading restricted

- 9. Delivery vehicles shall not load or off-load on—
  - (a) Saddle Road, from Mission Road to Eastern Main Road, from 9.30 a.m. to 2.00 p.m.; and
  - (b) Prizgar Road, from 10.00 a.m. to 2.00 p.m.

#### GENERAL

Offence and penalty

10. A person who contravenes any of the provisions of these Regulations is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars and on any subsequent conviction, to a fine of one thousand dollars.

11. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in  $^{\rm impounding}_{\rm of \, vehicles}$  contravention of these Regulations, may be removed by the Police and unlawfully impounded and dealt with in accordance with section 108(1)(b) of the  $^{\rm parked}$  Motor Vehicles and Road Traffic Act.
