Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

- THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (REPUBLIC OF TRINIDAD AND TOBAGO FORTY-SEVENTH ANNIVERSARY OF INDEPENDENCE CELEBRATIONS) ORDER, 2009
- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Republic of Trinidad and Tobago Forty-seventh Anniversary of Independence Celebrations) Order, 2009.
- 2. This Order has effect from 6.00 a.m. on Monday 31st August, Duration 2009 to 1.00 a.m. on Tuesday 1st September, 2009.
 - 3. (1) Motorists are prohibited from parking—

Parking prohibited

- (a) from 6.00 a.m. to 12.00 midday on—
 - (i) Queen's Park East;
 - (ii) Queen's Park West;
 - (iii) Circular Road;
 - (iv) Maraval Road;
 - (v) Charlotte Street, between the junction of Queen's Park East and Queen's Park West and New Street;
 - (vi) Lucknow Street;
 - (vii) Robert Street;
 - (viii) Tragarete Road, between St. Vincent Street and Roxy Roundabout;
 - (ix) Western Main Road, between Tragarete Road and Long Circular Road;
 - (x) Saddle Road, between Maraval Roundabout and Rapsey Street;
 - (xi) Panka Street;
 - (xii) Gaston Johnson Street:
 - (xiii) Keate Street;
 - (xiv) Chancery Lane;

- (xv) Long Circular Road, between Barbados Road and Western Main Road;
- (xvi) Damian Street;
- (xvii) Norfolk Street;
- (xviii) Belmont Circular Road;
- (xix) Archer Street; and
- (xx) Jerningham Avenue, between Queen's Park East and Norfolk Street; and
- (b) from 12.00 midday on Monday 31st August, 2009, to 1.00 a.m. on Tuesday 1st September, 2009 on—
 - (i) Queen's Park West, from Chancery Lane to St. Clair Roundabout;
 - (ii) Maraval Road, from St. Clair Roundabout to Maraval Roundabout;
 - (iii) Circular Road, from Maraval Roundabout to St. Ann's Roundabout;
 - (iv) Queen's Park East, from the St. Ann's Roundabout to Queen's Park West;
 - (v) Charlotte Street, from Queen's Park West to New Street; and
 - (vi) Cadiz Road.

Vehicular traffic prohibited

- 4. Vehicular traffic is prohibited from 6.00 a.m. to 12.00 midday on—
 - (a) Tragarete Road, between St. Vincent Street and Roxy Roundabout;
 - (b) Western Main Road, between Lucknow Street and Roxy Roundabout;
 - (c) Maraval Road;
 - (d) Frederick Street, between Queen's Park West and Park Street; and
 - (e) Park Street, between Frederick Street and St. Vincent Street.

Removal and impounding of vehicles unlawfully parked 5. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.

6. Vehicles that are removed and impounded in accordance with Retrieval of clause 5 may be retrieved at the Traffic and Highway Patrol Branch, impounded No. 8 Abattoir Road, Sea Lots, Port-of-Spain.
