ORDER

MADE BY THE PRESIDENT UNDER SECTION 8 OF THE CUSTOMS ACT

THE CUSTOMS (COMMON EXTERNAL TARRIFF) (AMENDMENT)
(NO. 2) ORDER, 2009

1. This Order may be cited as the Customs (Common External Tariff) (Amendment) (No. 2) Order, 2009.

2. The rates of duty set out in the First Schedule to the Customs Act in relation to the goods carrying the headings and descriptions listed below in the First and Second Columns respectively, are amended to the respective rates of duty specified in the Third Column:
