NOTICE OF LAND LIKELY TO BE REQUIRED FOR A PUBLIC
PURPOSE

NOTICE is hereby given that it appears to the President that the corridors of several parcels of land described in the Schedule and situate in the Wards of Pointe-a-Pierre, Savana Grande, Naparima, Siparia and La Brea in the Counties of Victoria and St. Patrick, are lands likely to be needed for a purpose which in the opinion of the President is a public purpose: construction of infrastructure for the installation of electrical transmission lines.

SCHEDULE

A corridor traversing several parcels of land commencing at 668072E, 1149845N and traverses south-east until it meets School Street at 668933E, 1148652N. It then travels north-east, crossing Dairy Road at 669865E, 1148652N and continues in the same direction until 671494E, 1148987N, then in a south-easterly direction, crossing Cedar Hill Road at 671842E, 1146228N and continues south-east, crossing the Solomon Hochoy Highway at 672236E, 1145861N, Forres Park Road at 673437E, 1144774N and Caratal Road at 673846E, 1144108N. It continues in a south-easterly direction crossing Bonne Aventure Road at 674575E, 1143027N until it reaches 674821E, 1142570N, where it changes to a southerly direction until the line splits at 674739E, 1140791N. The western part traverses south-west and crosses the Guaracara-Tabaquite Road at 674639E, 1140090N and the eastern part travels south-east, crossing the Guaracara-Tabaquite Road at 675056E, 1140206N. The lines rejoin at 674660E, 1139877N and travels south-west until they meet the Reform Substation at 672118E, 1139622N.

A corridor traversing several parcels of land commencing at Reform with co-ordinates 673782E, 1138661N. The line then travels south-west, crossing the Naparima-Mayaro Road at 673338E, 1137711N and then southerly until 673360E, 1136821N. After which, it travels south-west and crosses the Manahambre Road at 672336E, 1135070N, Cipro Road at 671359E, 1133707N and continues south-west until it reaches 671836E, 1131422N, then in a southerly direction, crossing Papoure Road at 670967E, 1129911N and then in a westerly direction crossing the M2 Ring Road at 670087E, 1129909N and continues west until it reaches the Debe Substation at 668883E, 1129912N.

A corridor traversing several parcels of land commencing at the Debe Substation at 668605E, 1129949N and travels south-west until 667107E, 1127664N, then in a generally westerly direction crossing Pluck Road at 665067E, 1127545N until it reaches 663627E, 1127486N. It then travels south-west until it crosses the St. John River at 662349E, 1126539N, then west crossing the Siparia Old Road at 661375E, 1126386N, Fyzabad Road at 659396E, 1126651N, Silver Stream Road at 656381E, 1126788, Grant's Trace at 655276E, 1126720N and continues west until 652123E, 1126973N. It then travels north then north-west until it reaches Union Estate at 650653E, 1129672N.

A corridor traversing several parcels of land commencing at 668582E, 1129948N and heads south-west until 667146E, 1127648N, then in a south-easterly direction, crossing the Oropouche Drainage Scheme at 667383E, 1126973N. It continues south-east, crossing the Raju Trace Extension at 667649E, 1125459N and then heads south-west, crossing the San Francique Road at 667342E, 1124780N. It then traverses in a generally southerly direction and until it joins an existing transmission line at 667407E, 1123121N. The second phase commences at 667615E, 1123364N and travels in a south-easterly direction, crossing Station 10 Road at two intervals, 667689E, 1123293N and then 667736E, 1123144N. It continues in a generally southerly direction, until 667778E, 1122679N and then in a south-westerly direction where it meets the Penal-Quinam Road at 667559E, 1122679N. It then parallels the eastern boundary of the Penal-Quinam Road, heading in a generally southerly direction until 667586E, 1121623N. From there, it travels west until 667033E, 1121682N.
