ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (STEELBAND PANORAMA) ORDER, 2009

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Steelband Panorama) Order, 2009.
 - 2. This Order shall have effect on the following times and dates:
 - (a) from 10.00 a.m. on Sunday 8th February, 2009 to 2.00 a.m. on Monday 9th February, 2009; and
 - (b) from 5.00 p.m. on Saturday 21st February, 2009 to 4.00 a.m. on Sunday 22nd February, 2009.
 - 3. Parking is prohibited on:

Parking prohibited

- (a) Queen's Park West, between Queen's Park East and Stanmore Avenue;
- (b) Chancery Lane;
- (c) Albion Street, between Victoria Avenue and Chancery Lane;
- (d) Pembroke Street, between Keate Street and Gordon Street;
- (e) Frederick Street, between Queen's Park West and Gordon Street;
- (f) Keate Street;
- (g) Queen's Park East, between Jerningham Avenue and Queen's Park West;
- (h) Charlotte Street, between Queen's Park West and New Street;
- (i) Gordon Street, between Charlotte Street and Dundonald Street;
- (j) Victoria Avenue, between Queen's Park West and Albion Street, except for taxis at the Queen's Park Taxi Stand; and
- (k) Dundonald Street, between Melville Lane and Queen's Park West.

Parking permitted

- 4. (1) Parking of vehicles is permitted on:
 - (a) Stanmore Avenue, between Queen's Park West and Tranquillity Street, on the western side;
 - (b) Victoria Avenue, between Albion Street and Tragarete Road, on the eastern side; and
 - (c) Dere Street, between Cummins Lane and Melville Lane, on the western side.
- (2) Parking is permitted for Public Transport Service Corporation buses, on the eastern side of Dundonald Street, south of Melville Lane.

One-way traffic

- 5. Vehicular traffic shall proceed on—
 - (a) Keate Street, between Charlotte Street and Chancery Lane, in a westerly direction only;
 - (b) Chancery Lane, between Keate Street and Albion Street, in a northerly direction only; and
 - (c) Albion Street, in a westerly direction only.

Two-way traffic 6. Vehicular traffic may proceed in both directions along Gordon Street, between Chancery Lane and Frederick Street.

Roads closed

- 7. (1) Vehicular traffic is prohibited on the following:
 - (a) Frederick Street, between Keate Street and Queen's Park West; and
 - (b) Queen's Park West, between Queen's Park East and Cipriani Boulevard.
- (2) Notwithstanding subclause (1)(b), vehicles conveying steelband instruments are permitted along Queen's Park West, between Queen's Park East and Cipriani Boulevard.

Parking in Queen's Park Savannah 8. Vehicles may be parked in the Queen's Park Savannah in accordance with the directions of police officers on duty.

Removal and impounding of vehicles unlawfully parked

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
