NOTICE is hereby given that the National Gas Company of Trinidad and Tobago Limited is desirous of executing a new project involving the establishment of 203.2 mm (8-inch) diameter Natural Gas Pipeline Pumping Facility, Fuel Storage and Tank Wagon Distribution Rack for the transportation of liquid fuel from the Petroleum Company of Trinidad and Tobago Limited Pointe-a-Pierre Refinery to the National Petroleum Marketing Company facility at Piarco. This project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, as amended by the Certificate of Environmental Clearance (Designated Activity) (Amendment) Order, 2007, thus requiring a Certificate of Environmental Clearance ("the Certificate") pursuant to section 35 of the Environmental Management Act, ("the Act").
