REGULATIONS

Made by the President under section 263(1) of the Customs Act

THE CUSTOMS (FEES) (AMENDMENT) REGULATIONS, 2009

- 1. These Regulations may be cited as the Customs (Fees) Citation (Amendment) Regulations, 2009.
- 2. In these Regulations, "Regulation" or "Regulations" means the Interpretation Customs (Fees) Regulations, 1957. $\frac{\text{G.N. No. 44}}{\text{of 1957}}$
- 3. Regulation 4 of the Regulations is amended in subregula- $_{\rm Regulation\ 4}$ tion (1)—
 - (a) by deleting paragraph (a) and substituting the following:

"(a) on ordinary weekdays—

Coxswain \$49.34 for each hour or part thereof;

Engineer

Senior \$54.92 for each hour or part thereof;

Coxswain Engineer

Customs \$57.55 for each hour or part thereof;

and Excise Guard

Customs \$67.84 for each hour or part thereof;

and Excise Supervisor on Saturdays, Sundays and public holidays-

- (f) in paragraph (f), by deleting the words "\$159.88" and substituting the words "\$203.51";
- (g) in paragraph (g), by deleting the words "\$159.88" and substituting the words "\$203.51"; and
- (h) in paragraph (h), by deleting the words "\$159.88" and "\$79.93" and substituting the words "\$203.51" and "\$101.76", respectively.

4. Regulation 4A of the Regulations is revoked and the following Regulation 4A revoked and regulation is substituted:

"Overtime fees 4A. (1) The overtime fees for duties performed by the officers specified in the Schedule, for any period of time in excess of the hours set out in these Regulations, are payable to the Comptroller at the rates and for the years indicated in the Schedule.

Schedule

- (2) The fees specified in the Schedule in respect of— $\,$
 - (a) the year 2005, are deemed to have come into effect on 1st January, 2005;
 - (b) the year 2006, are deemed to have come into effect on 1st January, 2006; and
 - (c) the year 2007, are deemed to have come into effect on 1st January, 2007.

(Regulation 4A)

- (3) Notwithstanding subregulation (1), any person who utilized any of the services mentioned in the Schedule shall be exempt from the payment of any sums of monies representing the difference between the rates which were payable, in respect of those services, before 1st January, 2005 and the rates set out in the Schedule.".
- 5. The Schedule to the Regulations is repealed and the following Schedule Schedule is substituted:
