REGULATIONS

Made by the Commissioner of Police with the consent of the MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (NO. 2) REGULATIONS, 2009

- 1. These Regulations may be cited as the Traffic Control Citation (Experimental Scheme) (No. 2) Regulations, 2009.
- 2. These Regulations shall have effect from Monday 6th April, Duration 2009 to Monday 29th June, 2009.

PRINCES TOWN

3. Motorists shall proceed in a—

One-way traffic

- (a) northerly direction on Charlotte Street;
- (b) southerly direction on Bonanza Street;
- (c) westerly direction on Tramway Street, between Railway Road (east) and Railway Road (west); and
- (d) southerly direction on Buen Intento Road, from Theodore Street to Naparima-Mayaro Road.
- 4. Parking is prohibited on—

Parking

- (a) High Street (Naparima-Mayaro Road), between King Street prohibited and Lothians Road;
- (b) King Street, between Naparima-Mayaro Road and Waterlane Street;
- (c) Buen Intento Road, between Naparima-Mayaro Road and Theodore Street;
- (d) Railway Road, between Naparima-Mayaro Road and Tramway Street;
- (e) Lothians Road, between Naparima-Mayaro Road and Armour Street;
- (f) the eastern side of Charlotte Street;
- (g) the eastern side of Bonanza Street;

- (h) the northern side of Waterlane Street; and
- (i) Armour Street.

Parking permitted

- 5. Parking is permitted on the—
 - (a) western side of Charlotte Street;
 - (b) western side of Bonanza Street;
 - (c) southern side of Waterlane Street;
 - (d) northern side of French Street;
 - (e) western side of Tramline Street, between Naparima-Mayaro Road and Tramway Street; and
 - (f) western side of Morton Street.

No right turn

6. Motorists proceeding west along Naparima-Mayaro Road shall not turn right onto—

- (a) Railway Road; and
- (b) Buen Intento Road.

No right turn

7. Motorists—

- (a) proceeding south along Railway Road shall not turn right onto Naparima-Mayaro Road; and
- (b) exiting the Princes Town Car-Park shall not turn right onto Naparima-Mayaro Road.

Stopping or waiting prohibited

- 8. Motorists are prohibited from stopping or waiting on—
 - (a) King Street, from Naparima-Mayaro Road to a point one hundred metres north; and
 - (b) Naparima-Mayaro Road, from Bonanza Street to Lothians Road.

Taxi stands

- 9. Taxis plying for hire shall park as follows:
 - (a) a maximum of thirty-three taxis facing south shall park on the eastern side of Buen Intento Road and extending onto the northern side of Naparima-Mayaro Road, facing east;
 - (b) a maximum of fifteen taxis facing east shall park on the northern side of the Naparima-Mayaro Road, from Railway Road and extending westwards;
 - (c) a maximum of thirteen taxis facing east shall park on the northern side of Cacique Street;
 - (d) a maximum of six taxis facing south shall park on the western side of Bonanza Street, from the Naparima-Mayaro Road and extending southwards; and
 - (e) a maximum of four taxis facing east shall park on the southern side of Tramline Street, from Lothians Junction and extending westwards.

10. Maxi-taxis plying for hire shall park as follows:

Maxi-taxi stands

- (a) a maximum of twenty-two maxi-taxis operating on the Princes Town to San Fernando route shall park facing east on the southern side of Tramline Street, from Railway Road and extending westwards, as marked; and
- (b) a maximum of forty-four maxi-taxis operating on the Princes Town to Rio Claro, Tableland, Moruga, St. Mary's, Sixth Company, Circular Road and New Grant routes, shall park facing south on the western side of the Princes Town Car Park, as marked.

Couva

- 11. Vehicular trafic shall proceed in a southerly direction on One-way Church Street, between Balisier Street and Church Street Extension.
- 12. Parking is prohibited on Church Street, between Balisier Street Parking and Church Street Extension.

CHAGUANAS

13. Parking is prohibited on—

Parking prohibited

- (a) Southern Main Road, from Factory Road to the Triangle, Chase Village; and
- (b) Factory Road, from Southern Main Road to Perseverance Road.

St. Helena

14. Parking is prohibited on—

Parking prohibited

- (a) Golden Grove Road, from Caroni South Bank Road to Caroni North Bank Road and Golden Grove Road intersection; and
- (b) Caroni South Bank Road, for two hundred metres east and west of Golden Grove Road.

GENERAL

- 15. A person who contravenes any of the provisions of these Offence and Regulations is liable on summary conviction for a first offence, to a fine penalty of seven hundred and fifty dollars, and on any subsequent conviction, to a fine of one thousand dollars.
- 16. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in impounding of vehicles unlawfully contravention of these Regulations, may be removed by the Police and parked

impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
