The object of the Bill is to supplement the appropriation provided for by the Appropriation (Financial Year 2012) Act, 2011 (Act No. 19 of 2011) by authorizing the issue from the Consolidated Fund in the sum of One Thousand, Five Hundred and Forty-Three Million, Five Hundred and Ninety Thousand, Seven Hundred Dollars (\$1,543,590,700).
