THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has received financing from the Inter-American Development Bank (IDB), and intends to apply part of the proceeds to payments under the project, Electronic Government and Knowledge Brokering Program for Consulting Services to eliminate the congestion of a backlog of records at the National Archives of Trinidad and Tobago. At present, there is a backlog of unprocessed records at the Record Centre which arose due to poor record keeping systems at the creating (original) offices and inadequate policies and procedures governing the operations of the Record Centre.

It is required that the consulting firm should have experience in best standards records management and possess a track record of successfully carrying out similar projects. The firm should possess technical and administrative capacity in policy and procedure development, development of operational plans, occupational, health and safety management, project management, knowledge and experience working in the public service.

In this regard, the Central Tenders Board on behalf of the Ministry of Public Administration invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information establishing that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).

The consulting firm should have experience in records management and have a successful track record of implementing projects of a similar nature. The firm should possess technical and administrative capacity in policy and procedure development, development of operational plans, occupational, health and safety management, project management and knowledge and experience working with the public service. Consultants may associate to enhance their qualifications.
