## APPOINTMENT OF A CUSTOMS AREA AND TRANSIT SHED

*(Customs Act, Chap. 78:01)*

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedules hereunder to be a Customs Area and Transit Shed for the storage, pending entry for home consumption or export, of the following goods, as shall be deposited in the Customs Area and Transit Shed of Messrs. Alstons Shipping Limited, Ansa McAl Centre, Corner of Uriah Butler Highway and Rodney Road, Chaguanas—General Goods and such other goods as I may subsequently approve.

## SCHEDULE I—CUSTOMS AREA

An area totalling 1,762.630 square metres comprising two smaller rectangular areas located within the south-eastern section of the second building north to south and one (1) rectangular area in the adjoining parking area east of the said section of the said building, forming part of the Ansa McAl Industries Warehouse Complex, owned by Ansa McAl and situated in the Ansa McAl Centre, Corner of Uriah Butler Highway and Rodney Road in the Borough of Chaguanas.

The dimensions of the Customs Area starting with the parking area which is outside the front of the said section of the said building on the eastern side are: 25.3 metres east to west from the concrete wall on the eastern side of the aforementioned section of the building and 65 metres north to south, starting from a point in line with the concrete wall separating the said section of the said building on the south, housing the Customs Area comprising a total of 1,644.500 square metres. This area is demarcated by painted yellow lines and signage on the north, east and south and on the west partly by the eastern wall of the aforementioned section of the building and partly by a painted yellow line. It is bounded on the north and south by lands of Ansa McAl abutted by Lange Park formerly part of Montrose Estate and on the west partly by the aforementioned section of the building and lands of Ansa McAl.

The second area is a holding bay within the aforementioned section of the building measuring 5.969 metres east to west and 17.119 metres north to south and including a corridor measuring 6.096 metres east to west and 2.616 metres north to south comprising a total of 118.130 square metres. This area is enclosed with concrete walls on the north and east, partly by a concrete wall and partly by B.R.C. wire mesh on the south and B.R.C. wire mesh on the west. It is bounded on the east by the parking area which forms part of the Customs Area and abutted by Lange Park formerly part of Montrose Estate; on the west partly by Standards Distributors Storage Area and partly by the Private Warehouse abutted by lands of Ansa McAl and abutted by the Uriah Butler Highway; on the north by lands and buildings of Ansa McAl and abutted by Rodney Road and on the south by lands of Ansa McAl abutted by Trinidad Publishing Company Limited.

The third area is within the aforementioned section of the building measuring 9.144 metres east to west and 5.486 metres north to south and comprising of 50.164 square metres. This area is enclosed with concrete walls on the east and south and B.R.C. wire mesh on the north and west. It is bounded on the east by an Office abutted by part of the Customs Area described in paragraph two (2) in Schedule (I), which is abutted by Lange Park formerly part of Montrose Estate; the west by the Private Warehouse and abutted by lands of Ansa McAl which is abutted by the Uriah Butler Highway; the north partly by part of Standard Distributors Storage Area and partly by part of the Customs Area described in paragraph three (3) as the second area in Schedule (I) and on the south by lands of Ansa McAl and Trinidad Publishing Company Limited.

## SCHEDULE II—Transit Shed

That part of the building constructed of concrete walls and B.R.C. wire mesh comprising one (1) rectangular area totalling 50.164 square metres located within the Customs Area which is described in Schedule I.

The dimensions of the Transit Shed are the same as described in paragraph four (4) as the third area in Schedule I.
