APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the Private Warehouse of Messrs, Unilever Caribbean Limited, Eastern Main Road, Champs Fleurs—Bar Soap, Liquid Soap, Body Spray, Shampoo, Conditioner, Toothpaste, Deodorant, Disinfectant and such other goods as I may subsequently approve.

An area totaling 2,131.19 square metres, comprising of two rectangular areas located within the northern-left and northern-central section of the 1st building west to east (Restrite Building) on the Unilever Caribbean Limited Compound leased from Kirrayne Limited and situate on the corner of Industrial Lane and the Eastern Main Road, Champs Fleurs in the County of St. George.

ORDER OF THE COMMISSION

WHEREAS Unilever Caribbean Limited ("the Respondent") has contravened section 66(3) of the Securities Industry Act, 1995 ("the Act") by failing to file with the Commission and issue a press release authorized by a senior officer within seven (7) days of the following:

- (i) The resignation of Mr. Pablo Garrido as a Director effective 19th May, 2011; and
- (ii) The appointment of Mr. Melvin Hernandez as a Director effective 19th May, 2011:

And whereas by letter dated 7th July, 2011, the Commission advised the Respondent that it was in contravention of section 66(3) of the Act, by failing to file with the Commission and issue a press release authorized by a senior officer within seven (7) days of the following:

- (i) The resignation of Mr. Pablo Garrido as a Director effective 19th May, 2011; and
- (ii) The appointment of Mr. Melvin Hernandez as a Director effective 19th May, 2011:

And whereas on the 11th day of May, 2012, the Respondent entered into a proposed settlement agreement with the Staff of the Commission which was signed by the duly authorized representative of the Commission for and on behalf of the Commission and the duly authorized representative of the Respondent, for and on behalf of the Respondent ("the Settlement Agreement"), in which the parties agreed to a settlement, subject to the approval of the Settlement Panel:

And whereas the Settlement Panel approved the Settlement Agreement and agreed to submit the Settlement Agreement to the Commission:

And whereas the Respondent shall pay to the Commission the sum of seven thousand dollars (\$7,000.00) within twenty-eight days of the making of this Order:

And whereas the Commission has considered the Settlement Agreement and is of the opinion that it is in the public interest to make this Order:

It is hereby ordered that—

- (a) the procedure outlined under the Securities Industry (Hearings and Settlements) Practice Rules, 2008 has been followed;
- (b) the Respondent has contravened section 66(3) of the Act and shall, within twenty-eight days of the making of this Order, pay to the Commission, as agent for the Comptroller of Accounts, the sum of seven thousand dollars (\$7,000.00) as the penalty in this matter; and
- (c) this Order shall be published in the *Trinidad and Tobago Gazette*, on the Commission's Website and in a daily newspaper.
