PRIVATE BILL—AN ACT TO REPEAL THE CARIBBEAN UNION COLLEGE (INCORPORATION) ACT, 1997 AND PROVIDE FOR THE UNIVERSITY OF THE SOUTHERN CARIBBEAN (INCORPORATION) ACT, 2012
