NEW GAME—SUPER LOTTO

Super Lotto is an add-on game to the existing Lotto Plus game. It is a multi-jurisdictional game which is currently being run in other jurisdictions in the Caribbean, i.e. — Anguilla, Antigua, St. Kitts and Nevis, United States Virgin Islands, Barbados, Dominican Republic and Jamaica.

The game offers players:

1. One (1) play of Lotto Plus and one (1) play Super Lotto for a total price of \$20. (Players can still purchase one (1) play of Lotto Plus for \$5).
2. A guaranteed US\$1.5 million minimum jackpot.
3. The option of choosing five (5) numbers out of a pool of thirty-five (35) numbers, and one (1) number out of a pool of ten (10) numbers.

Draw Venue—Super Lotto draws will take place in one location, in an authorized host country as agreed upon by the NLCB.
