

CLOSING DATE FOR NOMINATION OF CANDIDATES AT THE 26TH ANNUAL GENERAL MEETING 2012

All Attorneys at Law are advised that:

1. The Closing Date for Nomination of Candidates for election of Officers and Members of Council is **Friday 17th February, 2012**.
2. The Twenty-sixth Annual General Meeting of the Law Association of Trinidad and Tobago will be held on **Friday 16th March, 2012** in the **Convocation Hall, Knox Street, Hall of Justice, Port-of-Spain** commencing 3:00 p.m.
3. Nominations for the position of President, Vice President, Treasurer and fifteen (15) Ordinary Members (10 seniors and 5 juniors) must be made in writing on the prescribed Nomination Form.
4. Nomination Forms are obtainable in Port-of-Spain from the Secretariat of the Law Association and can be downloaded from the Association's website <http://www.lawassociationtt.com>.
5. Pursuant to paragraph 9(2) of Part II of the Legal Profession Act 1986 only practitioner members who pay their annual subscription to the Law Association are eligible: - (a) to attend and vote at a general meeting or at an election of members of the Council; or (b) to be elected to the Council.
6. Candidates as well as persons nominating them must be practitioner members of the Association. Every nomination of a candidate for election to the Association and the Council shall be signed by not less than five practitioner members and endorsed by the candidate.
