REGULATIONS

Made by the Commissioner of Police with the consent of the Minister of Transport under section 67(1) of the Motor VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (RIO CLARO/ GEORGE EARL PARK, St. JOSEPH) REGULATIONS, 2012

- 1. These Regulations may be cited as the Traffic Control Citation (Experimental Scheme) (Rio Claro/George Earl Park, St. Joseph) Regulations, 2012.
- 2. These Regulations shall have effect from Monday 21st May, Duration 2012 to Monday 20th August, 2012.

PART I

RIO CLARO

3. A driver shall proceed in a—

One-way traffic

- (a) northerly direction only along De Verteuil Street, between Dougdeen Street and Johnson Street; and
- (b) northerly direction only along Elie Street, between Naparima-Mayaro Road (High Street) and Circular Road, from 7.00 a.m. to 9.00 a.m.
- 4. A driver shall not park on—

Parking

- (a) Nathai Street, between Naparima-Mayaro Road (High Street) and Dougdeen Street;
- (b) Rio Claro-Guayaguayare Road, between Naparima-Mayaro Road (High Street) and Dougdeen Street;
- (c) Dougdeen Street, between Rio Claro-Guayaguayare Road and Nathai Street;
- (d) De Verteuil Street;
- (e) Tabaquite-Rio Claro Road, between Naparima-Mayaro Road (High Street) and Lalla Street;
- (f) Naparima-Mayaro Road (High Street), between Rio Claro roundabout and a point twenty metres east of Nathai Street;
- (g) Naparima-Mayaro Road (High Street), between Rio Claro roundabout and a point twenty metres west of Rio Claro-Guayaguayare Road; and
- (h) Johnson Street.

No entry to taxis and maxi-taxis

- 5. (1) A driver of a taxi or maxi-taxi proceeding along Naparima-Mayaro Road—
 - (a) in a westerly direction, shall turn left onto Nathai Street;
 - (b) in an easterly direction, shall turn right onto Rio Claro-Guayaguayare Road.
- (2) A driver operating a maxi-taxi shall not proceed along Tabaquite-Rio Claro Road, between Naparima-Mayaro Road (High Street) and Lalla Street.

Maxi-taxi stand

- 6. Maxi-taxis plying for hire shall be parked as follows:
 - (a) a maximum of eight maxi-taxis operating the Rio Claro/Princes Town route, in Lane 5 of the Rio Claro Transport Hub, facing north; and
 - (b) a maximum of four maxi-taxis operating the Rio Claro/Mayaro route, in Lane 1 of the Rio Claro Transport Hub, facing north.

Taxi stand

- 7. Taxis plying for hire shall be parked as follows:
 - (a) a maximum of eight taxis operating the Rio Claro/Princes Town route, in Lane 4 of the Rio Claro Transport Hub, facing north;
 - (b) a maximum of eight taxis operating the Rio Claro/Mayaro route, in Lane 3 of the Rio Claro Transport Hub, facing north;
 - (c) a maximum of five taxis operating the Rio Claro/Biche route, in Lane 2 of the Rio Claro Transport Hub, facing north; and
 - (d) a maximum of six taxis operating the Libertville/Poole/Rio Claro-Guayaguayare routes, in Lane 6 of the Rio Claro Transport Hub, facing north-west.

Stopping permitted 8. A person operating a maxi-taxi or taxi is permitted to stop on the eastern side of Rio Claro-Guayaguayare Road between a marked point twenty-five metres south and a marked point forty metres south of its intersection with Naparima-Mayaro Road (High Street).

PART II

GEORGE EARL PARK, ST. JOSEPH

No parking

- 9. A driver shall not park on the—
 - (a) southern side of Richmond Street, between Abercromby Street and Piccadilly Street;

- (b) northern side of Albert Street, between Abercromby Street and Piccadilly Street; and
- (c) western side of Piccadilly Street, from its intersection with Albert Street to a marked point twenty metres south.
- 10. A driver shall proceed in-

One-way traffic

- (a) an easterly direction only on Richmond Street, between Abercromby Street and Piccadilly Street, from 7.00 a.m. to 4.00 p.m. Monday to Friday, except on public holidays;
- (b) a northerly direction only on Piccadilly Street, between Richmond Street and Savary Street, from 7.00 a.m. to 4.00 p.m. Monday to Friday, except on public holidays; and
- (c) an easterly direction on Albert Street, between Abercromby Street and Piccadilly Street, from 7.00 a.m. to 4.00 p.m. Monday to Friday, except on public holidays.

PART III GENERAL

- 11. A person who contravenes any of the provisions of these _{Offence and} Regulations is liable on summary conviction for a first offence to a fine penalty of seven hundred and fifty dollars, and on any subsequent conviction, to a fine of one thousand dollars.
- 12. Without prejudice to any other liability incurred by the $_{\rm Removal\,and}$ commission of a summary offence, vehicles found parked in impounding contravention of these Regulations may be removed by the Police and of vehicles unlawfully impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
