Made by the Commissioner of Police under Section 68 of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (ST. JAMES COMMUNITY IMPROVEMENT COMMITTEE OF STEELBANDS) ORDER, 2012

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (St. James Community Improvement Committee of Steelbands) Order, 2012.
- 2. This Order has effect between the hours of 6.00 p.m. on Saturday $_{Duration}$ 9th June, 2012 and 3.00 a.m. on Sunday 10th June, 2012.
- 3. Parking and vehicular traffic are prohibited on the Western Main Parking and Road, between Roxy Roundabout and George Cabral Street.

- 4. (1) Vehicular traffic proceeding west along the Western Main $_{\text{Traffic routes}}$ Road shall proceed south onto Damian Street and then onto Mucurapo Road.
- (2) Vehicular traffic proceeding east along the Western Main Road shall proceed north onto George Cabral Street, east onto Kathleen Street, then along Delhi Street and onto Barbados Road.
 - 5. Parking is prohibited on—

No parking

- (a) Damian Street;
- (b) George Cabral Street;
- (c) Kathleen Street; and
- (d) Delhi Street.
- 6. (1) Vehicular traffic on the southern side of Church Street shall $_{
 m Vehicular}$ proceed in a northerly direction only along—
 - (a) Salazar Street;
 - (b) Jerry Street;
 - (c) Bournes Road;
 - (d) Brunton Street;
 - (e) Mooneram Street; and
 - (f) Bombay Street.

- (2) Vehicular traffic on the southern side of Delhi Street shall proceed in a northerly direction only along—
 - (a) Calcutta Street;
 - (b) Madras Street;
 - (c) Agra Street; and
 - (d) Bengal Street.
- (3) Vehicular traffic on the southern side of Carlton Avenue shall proceed in a northerly direction only along—
 - (a) Luckput Street;
 - (b) Mathura Street;
 - (c) Romeo Street; and
 - (d) Lazare Street.
- (4) Vehicular traffic on the northern side of Bay Road shall proceed in a southerly direction only along Ethel Street.
- (5) Vehicular traffic on the northern side of Anderson Street shall proceed in a southerly direction only along—
 - (a) Dengue Street;
 - (b) Vidale Street:
 - (c) Clarence Street; and
 - (d) Nizam Street.
- (6) Vehicular traffic on the northern side of Hyderabad Street shall proceed in a southerly direction only along—
 - (a) Nepaul Street;
 - (b) Cawnpore Street;
 - (c) Benares Street; and
 - (d) Lucknow Street.

Removal and impounding of vehicles unlawfully parked 7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
