CLEARANCE WHICH REQUIRES AN ENVIRONMENTAL
IMPACT ASSESSMENT SUBMITTED BY MORA OIL
VENTURES LIMITED

NOTICE is hereby given that Mora Oil Ventures Limited is desirous of drilling one (1) exploratory well and four (4) production wells, from the existing Mora A Platform, in the Mora Block, off the East Coast of Trinidad and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, thus requiring a Certificate of Environmental Clearance pursuant to section 35 of the Environmental Management Act, Chap. 35:05 (“the Act”). Mora Oil Ventures Limited has applied for a Certificate of Environmental Clearance (“the Certificate”) from the Environmental Management Authority (“the Authority”) for this project.

And take notice that the comments of the public are hereby invited on the application for the drilling of one (1) exploratory well and four (4) production wells, from the existing Mora A platform, in the Mora Block, which requires an Environmental Impact Assessment.

And take notice that the Authority has, for the purposes of the Certificate and pursuant to section 28(1)(b) of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter
